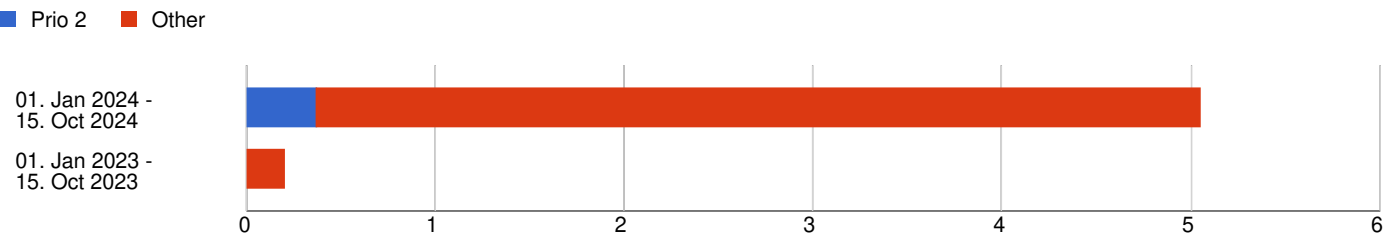

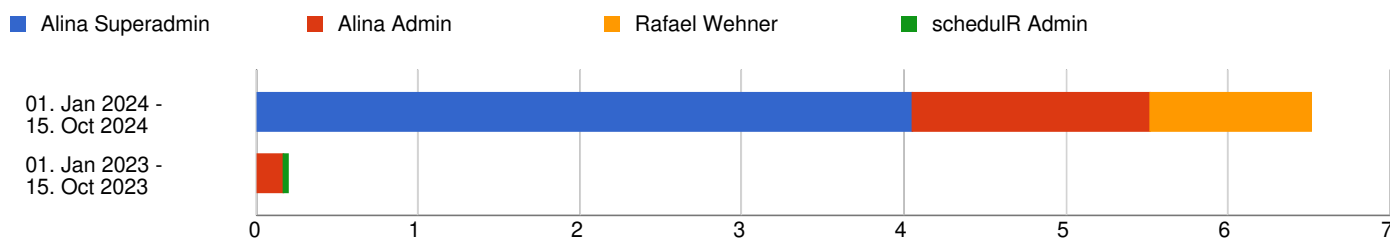

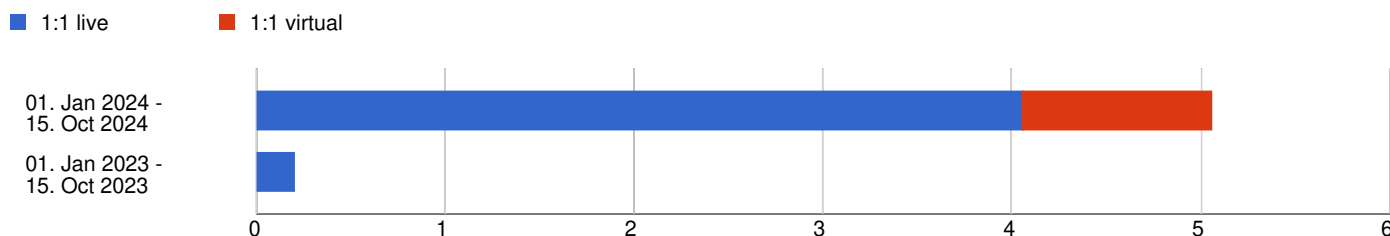

This means the sum of this table will be most likely higher than the summary figure. However, it correctly displays the interactions/time spent per internal participant. If an internal participant has a 100% here, it means she participated in every single investor interaction during the period. Also, if total internal participants attended e.g. 150% of interactions/time spent it means that on average 1.5 internal participants attended each meeting.

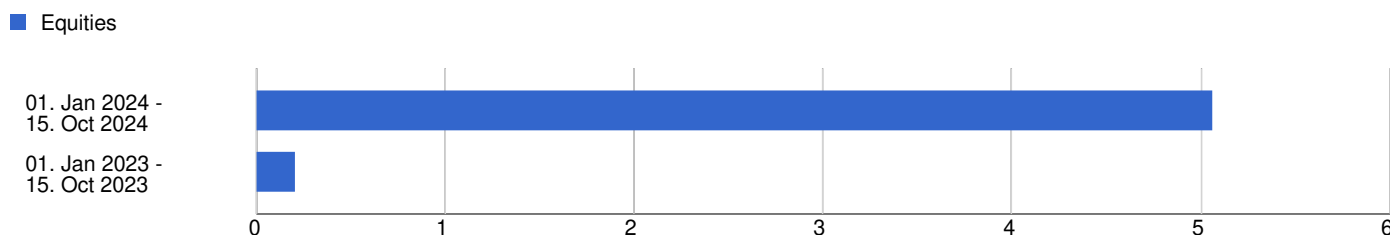

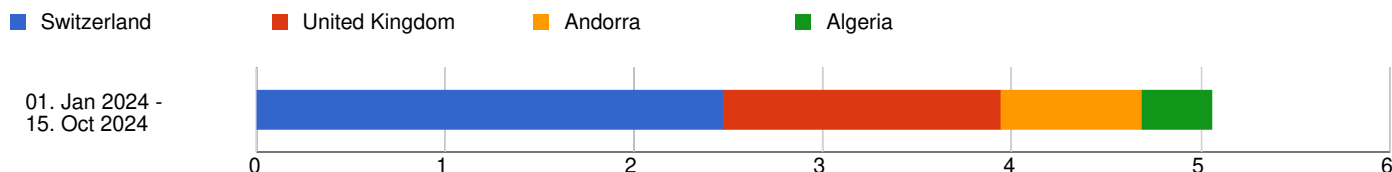

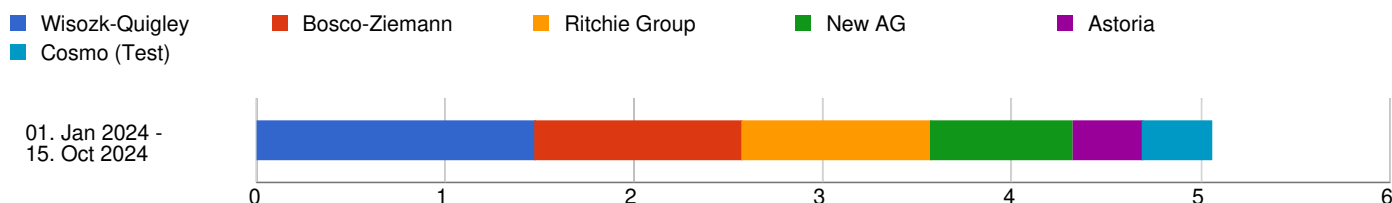
